CONSENT AGENDA

Terri went over the agenda for the evening and an overview of the various task forces, the Hotchkiss retreat.

DISCUSSION

Sanctuary Task Force

Dorit reported on an asylum family being cared for by a member church of the Dane Coalition. Volunteer training for "know your rights" was conducted at FUS for 11 people. We can only do one asylum or one sanctuary at a time. Dorit thinks we could not have multiple adults and multiple children in sanctuary because the building is too open. Tom asked pertinent questions about the staff report.

Ministerial Research Task Force

We had a discussion on what the task force matrix would contain. The Task force will attempt to highlight the salient points of each congregation for the board. What type of ministry does each church team have. How does it relate to the congregation. Discussion was also undertaken on how we communicate to the larger congregation the type of ministry we are looking for as our new minister.

September Parish Meeting Review

Kelly was concerned that we were just barely at quorum for the parish meeting with 71 people present at the start of the meeting. We looked at various methods to increase the advertisement of upcoming meetings. Have meetings in different venues at different times.
